

PURPOSE


OUTLOOK

Danville's economy appears to have stabilized and is beginning to recover from its long economic downturn and the effects of the recent national recession. With the exception of normal cyclical trends, key indicators reported here show several months without significant declines. Danville's unemployment rate is still high and construction and business activities remain sluggish. However, the City is now primed for economic growth.
